## ANNEXED NOTE

### 1. Technical Notes and Definitions

**Population of reference:** all individuals (nationals and non-nationals) residing in the Kingdom during the period of reference.

The ultimate sampling unit is the household.

**(a) Working age population:** the population aged 15 to 60 (retirement age for Saudis), even though (as of mid-2013) there is no maximum working age on foreign nationals.

**(b) Person in the labour force:** a person aged 15 years and over, employed or unemployed. Here, concerned population is aged 15 to 60 years.

**(c) Person out of the labour force:** A person aged 15 years and over who is

not included in the labour force, among which: the persons staying home for domestic activities, the students, the retired, the self sufficient, the ones unable to enrol in labour, who are not working and do not look for employment for any other reason. Here, concerned population is aged 15 to 60 years.
